Sub:- Recognition of Chinmaya International Foundation, Kerala as Shodha Sansthan under the Scheme of Financial Assistant to Institute recognized as Adarsh Sanskrit Mahavidyalaya and Shodha Sansthan under the Sansthan.

Sir,

With the approval of the Ministry of HRD vide their Letter No. F.No. 14-14/2003-Skt-I dated 13.2.08, I am directed to convey the approval of the competent authority to the recognition of Chinmaya International Foundation, Veliyanad, Kerala as Shodha Sansthan under the Scheme of "Financial Assistance to the Institute recognized as Adarsh Sanskrit Mahavidyalaya/Shodha Sansthan" (Copy of the Scheme is enclosed for guidance). The Foundation has been recognized as Shodha Sansthan w.e.f. the date of issue of this letter and its working will be regulated as per the Scheme amended from time to time. The Foundation is recognized as Shodha Sansthan with the objectives specifically mentioned in the Memorandum & Articles of Association of the Foundation for the development and research of Sanskrit and the Foundation is also expected to have activities of (i) conduction seminars (ii) conferences (iii) spoken Sanskrit classes (iv) evening Sanskrit teaching classes and (v) various kinds of competitions at city, district and state levels. The foundation is also expected to institute various awards/prizes for young writers, young researchers and renowned scholars. The Foundation may also launch a Scheme of giving awards for best books published in Sanskrit. It may also undertake various such activities which result in building up the atmosphere of Sanskrit in general apart from its main task of research and publication. In this regard, it has also recommended that the Foundation may study the activities and procedures of Delhi Sanskrit Academy as a model to launch all these activities.

The number of the posts in Research and Administration of the Shodha Sansthan has been sanctioned as per details given below:

No additional post will be created nor any recruitment other than the sanctioned post mentioned above made unless prior approval of the Rashtriya Sanskrit Sansthan ( as per the provisions of the Scheme) has been obtained and provision made to meet the expenditure.

The Government of India considered the recommendations of the screening committee and have agreed to absorb the following existing staff of Chinmaya International Foundation against the post sanctioned for the Shodha Sansthan.

The following existing staff of the Shodha Sansthan may be absorbed w.e.f. the date of recognition.

1. Smt. Rajalakshmi C.V. Librarian (MA. BLISC) in the pay scale of Rs.8000-13500 on the condition that she will draw the minimum of the pay scale i.e. Rs. 8000/- plus allowances as applicable in the State govt. of Kerala on the date of absorbtion.
2. Ms Sreelekha M.S. Typist (B.A. English) In the pay scale as applicable in the State Govt. run Colleges in the State and on the condition that she will draw the minimum of the pay scale plus allowances as applicable in the State Govt. of Kerala on the date of absorbtion.

3. Kishore M.B. Peon (BA) In the pay scale as applicable in the State Govt. run Colleges in the State and on the condition that she will draw the minimum of the pay scale plus allowances as applicable in the State Govt. of Kerala on the date of absorption.
4. Suresh V.K. Peon (BA) in the pay scale as applicable in the State Govt. run Colleges in the State and on the condition that she will draw the minimum of the pay scale plus allowances as applicable in the State Govt. of Kerala on the date of absorption.
5. Smt. Sarla Kumari N.D. Research Fellow in the pay scale of Rs. 5500-9000 on the condition that she will draw the minimum of the pay scale i.e. Rs. 5500/-plus allowances as applicable in the State Govt. of Kerala on the date of absorption.

Before absorption an undertaking to the effect that the individual will abide by all the services conditions mentioned in the Scheme and the age of retirement of the individual will be the same as applicable to their counter parts in the Govt. run Colleges in the State. The present age of retirement in the State is 55 years which will be applicable to the absorbed/appointed employees. If the terms and conditions are acceptable to them they can be absorbed.

After the absorption of above employee the following posts will remain vacant and the posts may be advertised and filled up as per the Scheme with the approval of the Sansthan. The Selection Committee for each post will be constituted by the Rashtriya Sanskrit Sansthan.

1. Director - One
2. Dy. Director - Two
3. Curator - One
4. Research Fellow- One

All appointments shall be made after these are duly considered and approved by the Managing Committee of the Shodha Sansthan constituted as per the Scheme of Adarsh Sanskrit Shodha Sansthan.

The Rashtriya Sanskrit Sansthan will financially assist the Shodha Sansthan @ 95% of approved expenditure on recurring items of expenditure and @ 75% on Non-recurring items of expenditure on year to year basis and the budget will be finalized on the recommendation of the Managing Committee. The budget will, however, depend on availability of funds every

year. The expenditure on the Shodha Sansthan will be met out of the sanctioned budget under plan of the Sansthan. The grants will be released to the institution on year to year basis on submitting the budget duly approved by the Managing Committee alongwith the bond and stamped receipt duly approved by the Chairman.

The release of grant will be considered after the budget is passed and recommended by the Managing Committee of the Shodha Sansthan. A bond and pre stamped receipt duly completed and signed by the Director and counter signed by the Chairman of the Managing Committee. The Managing Committee of the Shodha Sansthan is being constituted separately. The 5% of recurring and 25% on non-recurring items of approved expenditure will be met by the parent body of the Shodha Sansthan as per the Scheme. (copy enclosed)

The recognition is subject to depositing Rs. 2,00,000/- in the form of FDR in the name of the Foundation as required under the Scheme. Further that the Rashtriya Sanskrit Sansthan reserves the right to de-recognise the Foundation as Shodha Sansthan on a prior notice of three months in case the Foundation is found to deviate any provisions of the Scheme and/or any financial indiscipline or irregularity is noticed and if funds are not provided from the Ministry. Any future litigations or court cases will be under the jurisdiction of the Courts at New Delhi.

If the above terms & conditions are acceptable to the Foundation the same may be communicated to this office to enable us to process the case to release the grant to the Shodha Sansthan.
