I received a letter by post on 18-10-2021 from Central Sanskrit University (No.C.S.U./Adarsh/RTI/2021-22/517 dated 08-10-2021) regarding the above subject. According to the CIFSS records, reply to the RTI is as mentioned below.

**Question: Smt. C. V. Rajalekshmi, the Librarian of Chinmaya International Foundation Shodha Sansthan, Veliyanad, Ernakulam has not passed Net. Not taken Ph.D.**

**What is the criteria for C.V Rajalekshmi appointment as Librarian with Assistant Professor Grade salary at UGC Scale?**

**Answer: Smt. C. V. Rajalekshmi** is a permanent staff of CIFSS. She is now working as a Librarian in the pay scale of Rs.15600 - 39100 with AGP 6000 as per the old scheme (i.e. G.O.(P) No. 58/2010/H.Edn., Dated-27.03.2010, Higher Education (C) Department, Government of Kerala, para no.8.1). She is continuing till to date as per the old scheme. She is not getting any benefits according to the UGC Librarian.

It is to be noted that her recruitment was not a direct appointment. She was working as a Librarian in the Chinmaya International Foundation according to the state govt. guidelines. In 2008 she was absorbed by CIFSS Managing Committee in the Adarsh Shodha Sansthan Scheme at the Scheme implementation time, according to her duty and qualifications as per the old scheme.
